Kirkus Discoveries accepts for review any books not currently covered by *Kirkus Reviews*: pre-pub, post-pub, or out-of-print academic titles, poetry, PODs, e-books, mass-market, reference books, self-published books, etc.

- English translations and English-language submissions from outside the United States are also eligible.
- We require 2 copies of all submissions. Regardless of the published format (finished book, galley, manuscript, etc.), submissions must be received as hard copy, not electronic.
- In addition to the payment/registration form and signed legal agreement, please submit a one-page information sheet with *only* the following information: your name, address, phone number, e-mail address, a book synopsis and author biography.
- For notification of the arrival of your submission, please include a self-addressed, stamped postcard.

CUSTOMER AGREEMENT

This Agreement ("Agreement") is made on the date set forth below ("Effective Date") by and between the person or entity whose name and address are set forth below ("Customer" or "you"), and Nielsen Business Media, Inc. ("NBM"). By signing below or submitting a request for a review (the "Review") of a book (the "Book") by the Kirkus division of NBM, Customer hereby irrevocably and unconditionally agrees to the following terms and conditions:

1. You may not cancel this Agreement. However, NBM is under no obligation to provide the Review even if you sign this Agreement and send in payment. If NBM elects to provide the review, the Review process will begin after NBM receives payment, this signed and dated Agreement and two copies of the book to be reviewed (the "Book"). Standard reviews are generally completed and returned to Customer within seven to nine weeks, while expedited reviews are generally completed and returned to Customer within three to four weeks but there is no guarantee as to timing. Books are not processed on weekends or national holidays. Review will be no less than 250 words in length. The copies of the Book become the property of NBM and will not be returned to Customer. If NBM declines to provide a Review, Customer's payment and copies of the Book will be returned to Customer.
2. Customer may reproduce the Review partially or in its entirety for marketing or promotional purposes only. Customer may not add words to, or alter the integrity of the Review. In each use of the Review, Customer must include a prominent credit attributing the Review to "Kirkus Discoveries" (not "Kirkus Reviews"). If Customer incorrectly attributes the Review to "Kirkus Reviews," it must correct this error immediately, whether or not requested by NBM.
3. NBM will provide an objective, but not necessarily favorable, Review. No second reviews or refunds will be granted, regardless of the content or nature of the Review. NBM specifically disclaims all warranties, express or implied, including, but not limited to, warranties against non-infringement, and implied warranties of merchantability and fitness for a particular purpose. Customer has no legal recourse, and may not threaten or commence litigation, if it does not agree with the Review or finds it objectionable. Revisions of the Review will be considered only if it contains factual errors. Any revisions will be made at NBM's discretion.
4. The Review process is anonymous. Customer will not be informed of the individual chosen to write the Review. Customer cannot specifically choose a reviewer, nor make any requirements regarding the reviewer's age, gender, race, religion or professional background. Under no circumstances will Customer receive the reviewer's personal information.
5. You represent and warrant that you are authorized to submit the Book for a Review. Customer releases NBM, its affiliates, employees and reviewers, and shall indemnify, defend and hold them harmless from and against any and all liabilities, damages, losses, claims, costs and fees (including attorneys' fees) related to or arising in connection with the Review and any breach of this Agreement.
6. Customer may not assign this Agreement. This Agreement supersedes all prior agreements between NBM and Customer. This Agreement shall be construed and interpreted according to the laws of the State of New York without respect to its conflicts of law provisions and shall be binding upon the parties hereto, their heirs, successors, permitted assigns and representatives. Customer hereby submits to the exclusive personal jurisdiction of the federal and state courts located in New York County, NY, which shall have exclusive jurisdiction to hear and settle any and all matters involving the parties.
